July 2019

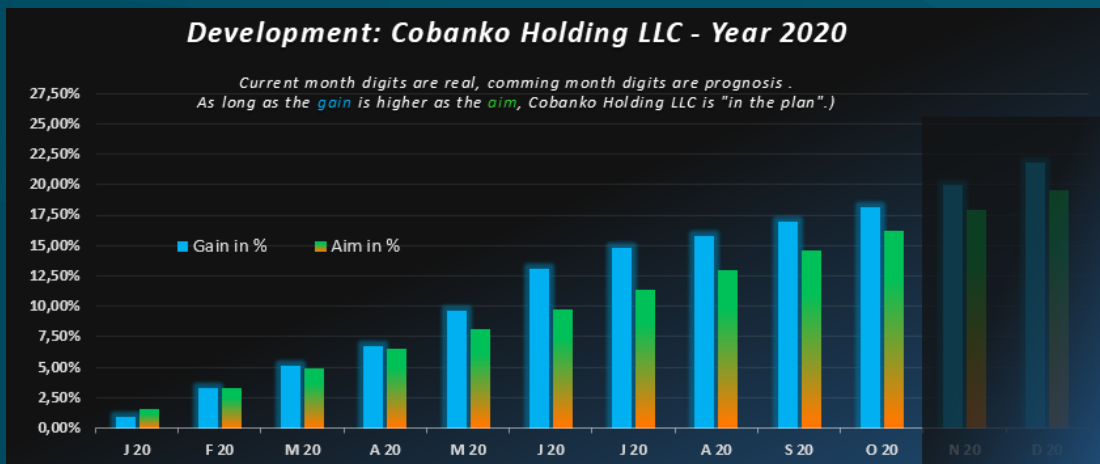
Acquisition of BIS and renaming to Cobanko, Inc.
